I, R.K. Srivastava, was appointed as the Scrutinizer by the Hon'ble Tribunal pursuant to orders dated April 24, 2025, May 15, 2025 and May 22, 2025 passed in Company Application No. CA(CAA) No. 20/ND/2025, for the purpose of scrutinizing the remote e-voting process prior to the meeting and e-voting during the NCLT convened meeting in a fair and transparent manner, of the Equity Shareholders of the Company to be held on September 27, 2025 at 03:00 P.M. IST through Video Conferencing / Other Audio-Visual Means ("VC"/ "OAVM") ("Meeting").

At 03:00 PM (IST), as communicated to the undersigned by Mr. Nitin Mahala, Assistant Manager, National Securities Depository Limited (NSDL) the quorum i.e. 1,84,336 members of the Company, as specified in NCLT Order was not present. As the requisite quorum was not present at the time scheduled for the meeting, hence, the Chairperson informed the shareholders present at the meeting, that the meeting would commence in accordance with the directions contained in the order, and therefore, the meeting was adjourned for half an hour as per the directions contained in the orders, and the persons present after half an hour adjournment were deemed to constitute a valid quorum and the meeting was called to order. The Meeting re-commenced at 03:35 PM (IST) and total 145 (One Hundred Forty-Five) participants attended the meeting.

General Circular No. 14/2020 dated 08.04.2020, 17/2020 dated 13.04.2020, 09/2023 dated 25.09.2023, and subsequent circulars issued by the Ministry of Corporate Affairs ("MCA") the latest being 09/2024 dated 19.09.2024 and other relevant circulars issued from time to time (collectively referred to as "MCA Circulars") and Circulars issued by the Securities and Exchange Board of India (SEBI) and the directions issued by NCLT vide its orders were followed in conducting the said meeting.

Subject to the above, I hereby submit my report as under:

1. Pursuant to the aforesaid orders of the Hon'ble NCLT, the Notice of the meeting along with the Explanatory Statement, copy of Scheme and other annexures referred to in the notice were sent to those equity shareholders whose names were appearing in the register of members /list of beneficial owners as received from Skyline Financial Services Pvt. Ltd, Registrar and Transfer Agent ("RTA") as on Friday, August 08, 2025 and whose emails addresses were registered with the Company/ Depositories. Emails were sent to 3,51,785 equity shareholders as on 08.08.2025 by the National Securities Depository Limited (NSDL) engaged by the transferee company on 25.08.2025. Further, equity shareholders whose email address were not registered, the notice together with the documents accompanying the same, were sent by the

- Company through physical mode by speed post to 12,772 equity shareholders. The Company published the notice on 27th August, 2025 in the Business Standard (English and Hindi, Delhi Edition) and also on its website www.integraessentia.com.
2. The Company had provided to its equity shareholders the facility to exercise their right to vote on the resolution included in the notice of the Meeting by remote e-voting and by e-voting at the meeting through the platform of National Securities Depository Limited ('NSDL'). The remote e-voting commenced on Wednesday, September 24, 2025, at 09:00 AM (IST) and was closed for voting on Friday, September 26, 2025, at 05:00 PM (IST).
 3. The equity shareholders of the Company as on the Cut-off Date, as set out in the Notice, i.e. Saturday, September 20, 2025, were entitled to vote on the proposed resolution as set-out in the Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the Cut-Off Date.
 4. After the conclusion of the Meeting, the details of voting through remote e-voting prior to the Meeting, e-voting at the meeting were unlocked and verified.
 5. I have scrutinized and reviewed the remote e-voting and e-voting during the Meeting based on the data downloaded from the website of NSDL.
 6. The meeting was concluded at 03:57 P.M. on September 27, 2025. The e-voting facility was kept open till 04:15 P.M. on September 27, 2025 to enable the equity shareholders to cast their vote, who could not cast their vote through remote e-voting. After the closure of time provided for e-voting facility, the e-voting platform was unblocked in the presence of 2 (Two) independent witnesses whose details are given below, and, the combined report had been generated based on the data downloaded from NSDL e-voting system.



7.
